PRODUCT SPECIFICATIONS

- Double rope 2m with 2 big snap hooks & 1 twist lock steel carabiner.
- Double lanyard is a component of personal protective equipment against falls from a height and complies with EN354.
- The lanyard LB 122 is made of \varnothing 12mm polyamide kernmantle rope. The ends of the lanyard are sewn making the connecting loops equipped with thimbles.
- Energy absorbers are a component of personal protection equipment. It is made from polyester webbing. Energy absorber made of 32 mm wide polyamide webbing. Absorber is equipped with attaching loops on the endings. The body of the absorber is protected by special jacket made of a shrinkable, polyethylene tube.
- Snap hook-AZ 022: galvanized steel: opening: 50 mm, weight: 500 g with eyelet, in nickel plated steel with automatic locking gate by safety catch, length 217 mm, opening 56 mm.
